#### TRANSPORTATION FUNDING OUTREACH, POLLING AND MARKETING UPDATE

Presentation provided by Matt Click, Executive Director, with Curt Below, FM3, and Cherri Spriggs, Meraki Public Affairs.

Matt introduced Curt Below of FM3 who provided the Board on the latest polling results. This presentation will be available on the PCTPA website: <a href="https://pctpa.net/2023-10-18-pctpa-board-meeting">pctpa.net/2023-10-18-pctpa-board-meeting</a>. Cherri provided an update on the funding strategy outreach and marketing efforts. The two, thirty second videos that are currently playing on the streaming platforms, i.e., Hulu, Roku, Peacock, were played. Public comment was provided by 1) Michael Garabedian, Placer County Tomorrow, and 2) Peter Eakland, Rocklin resident. This item was for information only. No action was taken.

#### **EXECUTIVE DIRECTOR'S REPORT**

Matt Click reported on the following:

- Nevada Station / New Office Space
  - The building will close on December 4th with a sales price of \$2.8 million. This is three days after our bond prepayment penalty expires which will save us approximately \$80,000.
  - The buyer waived contingencies on October 16th. The buyer, who is another public entity, will bring approximately 20 jobs to the Auburn area.
  - We are currently in negotiations for a space on Douglas Blvd. in Roseville. We are going from 6,000 square feet to about 3,200 square feet.
  - We currently spend about \$14,500 per month on rent. Our new rent will be \$8,300 per month with our first four months of rent free. Over the next eight years, the agency will save approximately \$600,000.
- Senate Bill 125
  - This is funding provided to assist transit providers to address the operational and capital needs of the transit system.
  - ✓ We are slated to receive \$37.85 million in TIRCP and ZETCP funding.
  - Staff is currently working with the jurisdictions on developing a list of priorities, such as EV charging and infrastructure, zero emission busses, and potentially working with CCJPA to provide some additional funds for the Phase 2 of the Third Track Project. Board updates to occur in December and January.
- PBA DC Trip
  - ✓ At the upcoming PBA trip, our federal lobbyist, TFG, will give a presentation on the state of funding at the federal level.

• Highway 49 Sidewalk Gap Closure Project

- ✓ The utility estimates from PG&E came in at \$1.7 million over the engineers' estimate.
- ✓ We need to align scope with budget, and, at a minimum, we'll need to 'descope' the project.
- \$14 million of the project funding is a grant approved by CTC. Rick Carter has been working with CTC staff and Caltrans in finding a solution to this funding shortfall.
- PCTPA SACOG Memorandum of Understanding (MOU)
  - As the federal MPO, SACOG must perform the air quality modeling, as well as other associated programmatic activities.
  - ✓ PCTPA and SACOG have an MOU that dates back to 1973.
  - ✓ In 1976 we agreed to give them 2% of our LTF contributions, with a cap of 10% per year. This led to PCTPA paying SACOG a substantial amount of money on an annual basis, with the annual contribution growing at a quicker rate than our per capita population due to the robust nature of our sales tax base.
  - ✓ It's anticipated that next year's contribution will be over \$522,000
  - We have engaged in conversations with SACOG over the past several months to discuss renegotiation of the MOU, and Matt recognized James Corless and Eric Johnson for their efforts and willingness to discuss the terms of the MOU.
  - ✓ We have a verbal commitment from Mr. Corless to reduce this to \$330,000, saving the agency obligation by approximately \$200,000.
  - Further, the rate at which this contribution escalates will no longer be attached to LTF.

SUBJECT: CONSENT CALENDAR

Below are the Consent Calendar items for the December 6, 2023, agenda for your review and action.

1. <u>Approval of the 2024 PCTPA, PCALUC, WPCTSA, and PCLTA Board Meetings</u>
Per Article 3.1 of the Placer County Transportation Planning Agency (PCTPA) Bylaws, the regularly scheduled meetings of the Placer County Transportation Planning Agency (PCTPA) Board shall be held on the fourth Wednesday of the month at 9:00 AM. Traditionally, the November and December PCTPA Board meetings have been combined to avoid any holiday conflicts. Special meetings may be held as needed in the manner specified by State law.

The Bylaws or Rules of Procedure of the Placer County Airport Land Use Commission (PCALUC), Western Placer Consolidated Transportation Services Agency (WPCTSA), and the Placer County Local Transportation Authority (PCLTA) dictate that their Board / Commission meetings be held at the same time as that of PCTPA. To that end, staff recommends approval of the 2024 PCTPA, PCALUC, WPCTSA, and PCLTA Board Meetings.

- 2. <u>FY 2023/24 City of Colfax Claim for Local Transportation Funds (LTF) \$139,904</u> The City of Colfax has submitted a claim for \$139,904 in LTF funds for FY 2023/24. The entirety of the claim is for Article 8a Local Streets and Roads purposes. The City's claims are in compliance with the approved LTF apportionment. Staff recommends approval, subject to the requirement that the City submit a complete Fiscal and Compliance Audit for the fiscal year ending June 30, 2023, and all transit needs that are reasonable to meet are being provided, prior to issuance of instructions to the County Auditor to pay the claimant in full.
- 3. <u>FY 2023/24 City of Colfax Claim for State Transit Assistance (STA) \$18,896</u> The City of Colfax has submitted claims for \$18,896 in STA funds for FY 2023/24 \$13,311 for transit capital and \$5,585 for contracted transit services. The City's claim is compliant with the approved STA apportionment and with all applicable STA requirements. Staff recommends approval.
- 4. FY 2023/24 Town of Loomis Claim for Local Transportation Funds (LTF) \$458,456
  The Town of Loomis has submitted a claim for \$458,456 in LTF funds for FY 2023/24. The entirety of the claim is for Article 8a Local Streets and Roads purposes. The Town's claims are in compliance with the approved LTF apportionment. Staff recommends approval, subject to the requirement that the Town submit a complete Fiscal and Compliance Audit for the fiscal year ending June 30, 2023, and all transit needs that are reasonable to meet are being provided, prior to issuance of instructions to the County Auditor to pay the claimant in full.

- 5. <u>FY 2023/24 Town of Loomis Claim for State Transit Assistance (STA) \$61,927</u> The Town of Loomis has submitted claims for \$61,927 in STA funds for FY 2023/24. The entirety of the claim is for contracted transit services. The Town's claim is compliant with the approved STA apportionment and with all applicable STA requirements. Staff recommends approval.
- 6. FY 2023/24 Western Placer Consolidated Transportation Services Agency Claim for Local Transportation Funds (LTF) \$733,045

  Western Placer CTSA is submitting a claim for \$733,045 in LTF funds for the FY 2023/24. The Western Placer CTSA claim complies with the approved LTF apportionment. Staff recommends conditional approval, subject to the Western Placer CTSA's authorization to submit the subject LTF claim.
- 7. FY 2023/24 Western Placer Consolidated Transportation Services Agency Claim for State
  Transit Assistance (STA) \$176,821
  Western Placer CTSA is submitting a claim for \$176,821 in STA funds for FY 2023/24 for transit purposes. The Western Placer CTSA claim complies with the approved STA apportionment and with all applicable STA requirements. Staff recommends conditional approval, subject to the Western Placer CTSA's authorization to submit the subject STA claim.
- 8. SR 49 Sidewalk Gap Closure Project Wood Rodgers Contract Amendment \$60,000 Authorize the Executive Director to execute a Letter of Task Agreement (attached) to complete engineering service for the SR 49 Sidewalk Gap Closure Project (Project) with Wood Rodgers, Inc., for an additional \$60,000, for a total not to exceed amount of \$1,595,165.48. The change is due to increased design costs for Wood Rodgers associated with design changes to meet budget constraints on the project. Wood Rodgers additional costs are not to exceed \$60,000 for this work. The necessary funds will be programmed to the PS&E phase from an expected influx of \$2 million in CMAQ funding following a funding swap with the Capitol Corridor Joint Powers Authority. The \$2 million funding swap was necessary to cover higher than expected utility relocation costs. Staff recommends approval.
- 9. SR 49 Sidewalk Gap Closure Project Monument Contract Amendment \$23,999.16
  Authorize the Executive Director to execute a Letter of Task Agreement (attached) to complete right-of-way services for the SR 49 Sidewalk Gap Closure Project (Project) with Monument, for an additional \$23,999.16, for a total not to exceed amount of \$706,682.48. The change is due to increased consultant costs from greater than expected utility coordination efforts, right-of-way coordination on design changes, and additional negotiations with property owners, including extending the duration of five Temporary Construction Easements (TCEs). The additional cost to complete the right-of-way support phase from Monument is \$23,999.16. The necessary funds will be covered by a \$2 million influx of funding to the project as a result of the funding swap with the CCJPA. The funding was necessary to cover higher than expected utility relocation costs. Staff recommends approval.
- 10. <u>SR 49 Sidewalk Gap Closure Project Approval of Construction Cooperative Agreement</u>
  PCTPA is working with Caltrans, Placer County, and the City of Auburn to construct a sidewalk gap closure project along a 4-mile stretch of SR 49 between I-80 and Dry Creek Rd.

PCTPA is the agency responsible for the PA&ED, PS&E, and right-of-way phases of the SR 49 Sidewalk Gap Closure Project. Caltrans will advertise, award, and administer (AAA) construction of the project. The project has advanced to the point where staff recommends that the PCTPA Board enter into a Cooperative Agreement with Caltrans for construction of the project. PCTPA is funding construction of the SR 49 Sidewalk Gap Closure Project with an Active Transportation Program Cycle 4 grant awarded in 2019. As such, a Cooperative Agreement is required with Caltrans to outline funding contributions, as well as identify roles and responsibilities in the construction of the project. These responsibilities have been reviewed and agreed to by staff of Caltrans and PCTPA.

There is no additional fiscal impact to the agency for entering into this cooperative agreement. PCTPA has already secured \$13.32 million in ATP funds for the construction of this project. Staff recommends authorizing the Chair and Executive Director to sign this cooperative agreement with Caltrans.

#### 11. Disposal of Surplus Property

Per the 2010 Administrative Policies, the Executive Director will bring to the Board a list of identified items to be designated as surplus property. Staff has recently identified surplus property that is no longer needed by PCTPA and/or has been or will be replaced. The majority of the items are part of the negotiated sale of the Nevada Station Building and falls into category B below. - E. Sale to Agency staff where the value of the individual item of surplus property is less than \$500 and PCTPA may realize reasonable profit;
- F. Disposal to local landfill or hazardous materials collection;
- G. Transfer to an auction company for sale at public auction.
- 12. SR 49 Sidewalk Gap Closure Project Amendments to PS&E & ROW Co-Op Agreements Authorize the Executive Director to amend the co-operative agreements with Caltrans for the PS&E phase and the ROW phase of the SR 49 Sidewalk Gap Closure Project. The amendments are necessary in order to add \$275,000 in CMAQ funds to the PS&E phase and \$1.725 million in CMAQ funds to the ROW phase. They will primarily be used to pay for additional design costs, PG&E utility relocation costs, and project contingency. The funds were realized through a fund swap with CCJPA with SB 125 TIRCP funds. Staff recommends approval.

Mr. Peterson:

The purpose of this letter is to request a budget augmentation for the SR-49 Highway Gap Closure right of way efforts.

The original project budget was predicated on the facts available to us when the contract was executed in February of 2021 and Amended in May 2023. Since then, additional time and efforts have been necessary.

#### **Project Management and Timeline:**

The last budget amendment anticipated a right of way certification in Spring 2023. The project was delayed and our efforts extended an additional 9 months. The extended project timeline has increased the overall Project Management budget necessary to see this project to completion.

Monument participated in Bi-weekly meetings with PCTPA and Wood Rogers as well as Bi-weekly focus meetings with Caltrans for that duration, totaling 36 meetings.

#### **Project Design:**

While in escrow, the authorized signers changed for Rock Creek Self Storage. The new representative did not agree to selling PCTPA a partial fee interest, but he would agree to a Slope Easement. Monument worked with design, PCTPA and Caltrans to determine if this change was acceptable. New documents had to be prepared and executed in order to proceed with the acquisition and close escrow.

As a result of the change in the right of way acquisition for Rock Creek Self Storage, the plat and legal needed to be amended for Auburn Parks and Recreation to correctly identify the access control line. This escrow had already closed, so Monument needed to be prepared, executed and recorded a Correction Deed.


Several TCE's were eliminated from the project. Monument coordinated with Wood Rogers on the updated mapping and provided a Recission Letter to 8 property owners. This documentation also needed to be reflected in the right of way certification and the supporting documents needed to be added to the files.

#### **TCE Extensions:**

Design identified 5 locations where the TCE's would need to be extended beyond the acquired 2 years. In order to comply with Caltrans' standards, an updated Fair Market Rent needed to be offered. Therefore, Monument updated waiver valuations and made updated offers to 5 owners. Amended PSA's and TCE's were prepared and executed. Monument prepared funds requests and coordinated check delivery with each of the property owners. This documentation also needed to be reflected in the right of way certification and the supporting documents needed to be added to the files.

#### **Utilities:**

In March 2023, design identified 3 alternatives for the bridge at Rock Creek. Additional coordination with PGE was required which also delayed the cost estimates for the relocation. Due to all the components of the PGE relocations, weekly meetings with PGE have been held since March 2023, totaling 34 meetings.





Due to construction funding requirements, a Utility Agreement needed to be prepared and executed for the PCSD as well which was not originally anticipated.

#### **Remaining Efforts:**

Monument will continue to coordinate with Caltrans ROW and PCTPA until project certification is obtained. We are still coordinating with PGE, so that encroachment permits can be obtained from Caltrans. We also anticipate attending Project and PDT meetings until Bid Award in February 2024. Monument will also close out the project and work with PCTPA on file delivery upon completion of the project.

We have expended approximately \$18,000 in efforts to date and anticipate a not to exceed amount of \$5,999.16 to complete the remaining tasks. We hereby request your approval of additional funds in the amount of \$23,999.16 as shown below to complete the remaining efforts.

(RTIP) ADOPTION

#### **ACTION REQUESTED**

Adopt Resolution 23-33, adopting the 2024 Regional Transportation Improvement Program (RTIP) for Placer County.

#### **BACKGROUND**

The State Transportation Improvement Program (STIP) is made up of two components: 75% comes from the Regional Transportation Improvement Programs (RTIPs) provided by each of the 58 counties, and 25% comes from Caltrans' Interregional Transportation Improvement Program (ITIP). Each STIP cycle, the California Transportation Commission (CTC) adopts a Fund Estimate of transportation money available over the following five years. This is then broken down by formula to specify a target "county share" amount for each Regional Transportation Planning Agency, such as Placer, to program their RTIP.

The current 2022 STIP covers Fiscal Year (FY) 2022/23 through 2026/27. The 2024 STIP adds two years, FY 2027/28 and FY 2028/29, to the current program. In 2002, the Board took a bold move to request a \$78 million advance of Placer's County shares to match a large commitment of Caltrans discretionary ITIP dollars to fully fund Phase 1 of the Lincoln Bypass. As a result, the 2024 STIP estimate indicates a negative balance of \$3.8 million for Placer County though FY 2028/29. Had the Board not taken this approach, the Lincoln Bypass would likely have never been funded and the City of Lincoln would be substantially different in nature. A result of the advance is that PCTPA will not receive funding other than Planning, Programming, and Monitoring funds until the advance is "paid off" around 2030. The 2026 STIP will likely include a small amount of STIP funding for FY 29/30 and FY 30/31.

#### **DISCUSSION**

Every two years, the CTC adopts a fund estimate projecting five-years of gas taxes to determine capacity in the STIP and State Highway Operations and Protection Program (SHOPP). As was done in the 2022 STIP cycle, the CTC has also asked agencies to discuss their region's interregional highway and intercity rail priority needs and asked for potential locations for the "State Highways to Boulevards" program in their RTIPs.

#### Highway Program

There is no capacity for Placer County to program new projects in the STIP because the 2024 STIP estimate shows a negative balance through FY 2028-29.

While PCTPA has an advance of funds, the CTC still allows us to program funds to support the Agency's requirements to plan, program, and monitor regional transportation projects. Staff therefore recommends the following as our 2024 RTIP submittal:

#### Planning, Programming, and Monitoring (PPM) - \$1.042 million RTIP

These funds cover the Agency's costs to plan, program, and monitor the projects contained in the RTIP and ITIP, to ensure that projects are within the scope and costs programmed, assuring that projects move as quickly as possible to construction, and that the timely use of funds requirements are met. The CTC is allowing us to program \$1,042,000 for FY 2024/25 through FY 2028/29.

Staff is recommending that the maximum amount of funds allowable be programmed in PPM as an offset of administrative funding from the Transportation Development Act (TDA)'s Local Transportation Fund (LTF). Staff is recommending the \$1,042,000 be apportioned as shown in the STIP fund estimate, with \$210,000 in each fiscal year from FY 2024/25 through FY 2027/28, and \$202,000 in FY 2028/29. This results in an increase of \$64,000 programmed for fiscal year FY 2024/25.

### Interregional Highway and Intercity Rail Needs and Potential Candidates for a State Highways to Boulevards Conversion Pilot Program

As in the previous cycle, the CTC has asked agencies to discuss their region's interregional highway and intercity rail priority needs and asked for potential locations for a "state highways to boulevards" pilot program in their RTIPs. The descriptions are the same as those provided in the 2022 RTIP, except for the addition of a study of managed lanes on SR65 between I-80 and Lincoln Blvd.

#### Interregional Highway and Intercity Rail Needs

- Reconstruction of the 80/65 interchange
- Widening and operation improvements on SR65 from Galleria Blvd to Lincoln Blvd
- Feasibility analysis of managed lanes on I-80 from the western county line to the SR65 interchange
- Feasibility studies for managed lanes on SR65 between I-80 and Lincoln Blvd
- Improvements on SR89 and 267 to support improved transit service in the Resort Triangle
- 3rd track expansion of the UPRR line between Roseville and Sacramento
- Feasibility studies for expanded passenger rail service to Tahoe/Reno/Sparks

#### Potential Candidates for a State Highways to Boulevards Conversion Pilot Program

- Construct continuous bicycle lanes and pedestrian facilities on Highway 49 in the City of Auburn between Lincoln Way and Dry Creek Rd (PM 2.3 to 7.5)
- Constructing bicycle and pedestrian overcrossing near the following locations:
  - o I-80 near Cirby Way
  - o I-80 near Rocklin Rd/ Sierra College
  - o SR 49 north of Bell Rd
  - o SR 49 near Palm Ave
  - SR65 near Blue Oaks Blvd
  - SR65 near Galleria Blvd

#### Section 3. Background of Regional Transportation Improvement Program (RTIP)

#### A. What is the Regional Transportation Improvement Program?

The Regional Transportation Improvement Program (RTIP) is a program of highway, local road, transit and active transportation projects that a region plans to fund with State and Federal revenue programmed by the California Transportation Commission in the State Transportation Improvement Program (STIP). The RTIP is developed biennially by the regions and is due to the Commission by December 15 of every odd numbered year. The program of projects in the RTIP is a subset of projects in the Regional Transportation Plan (RTP), a federally mandated master transportation plan which guides a region's transportation investments over a 20 to 25 year period. The RTP is based on all reasonably anticipated funding, including federal, state and local sources. Updated every 4 to 5 years, the RTP is developed through an extensive public participation process in the region and reflects the unique mobility, sustainability, and air quality needs of each region.

#### B. Regional Agency's Historical and Current Approach to developing the RTIP

As part of developing the adopted 2040 RTP (December 2019), PCTPA developed both quantitative and qualitative performance measures. The RTP is directly linked to the PCTPA RTIP in that the projects identified as part of the RTIP are also included in the funding constrained RTP.

PCTPA has a history of successful collaboration with Caltrans and local agencies to deliver regional transportation projects, including the \$325 million Highway 65 Lincoln Bypass in 2012, the largest transportation project in Placer County history. The Highway 65 Lincoln Bypass was delivered using both RTIP and ITIP funding, as well as other funding sources.

Measure M was placed on the November 2016 ballot in Placer County for a countywide transportation sales tax measure. The ½ cent sales tax measure received 64 percent support, just shy of the 2/3 majority needed to pass. The sales tax was estimated to generate \$1.6 billion over 30 years to be used for transportation projects in Placer County, including the proposed Interstate 80/State Route 65 interchange reconfiguration. PCTPA considered placing a sales tax measure on the 2020 ballot by put these plans on hold due to the impacts of the COVID-19 pandemic. PCTPA is now looking at a placing a transportation sales tax measure on the 2024 ballot.

#### Section 4. Completion of Prior RTIP Projects (Required per Section 78)

The last project completed in Placer County using STIP funding was Phase 1 of the Highway 65 Lincoln Bypass, which was completed in 2012. Significant STIP funding was advanced to complete the Lincoln Bypass that resulted in a project with significant benefits to the public but also resulted in an overdrawn balance of approximately \$3.8 million in fiscal year 2028-29 for Placer County's regional choice STIP funding. Because no funding was available, there were no projects completed in Placer County using STIP funding between adoption of the 2022 RTIP and the current 2024 RTIP.

#### B. Community Engagement

PCTPA actively solicits the participation of the general public as part of its ongoing transportation planning work. PCTPA includes outreach to Native American tribal governments, specifically, the United Auburn Indian Community. The adopted Placer County 2040 Regional Transportation Plan (December 4, 2019) Appendix B contains Interagency and Public Involvement Process. The outreach efforts for the Placer County 2040 RTP was a multipronged approach. PCTPA coordinated with SACOG on interagency consultation and coordination to identify project lists and future land use forecasts used in the evaluation of their Sustainable Communities Strategy (SCS) scenarios. Residents, civic groups, and the private sector were engaged through statistically valid phone polling, a pop-up workshop at the Sierra College Campus in Rocklin, and a series of three on-line surveys. The on-line surveys built upon the success of recent online outreach efforts and engaged over 2,300 residents. The surveys

provided a wealth of feedback for use far beyond the RTP. There were two key takeaways from the responders that were incorporated into the RTP. First, highways and congestion are a top priority. Throughout the surveys, Placer County's community made clear that traffic is a concern and the RTP's section on Regionally Significant Roadway Projects highlights how those concerns can be alleviated. This desire to alleviate congestion to improve quality of life has been a consistent theme through multiple RTP update processes. The second takeaway is that transportation funding is confusing. Particularly in the second survey, responders indicated that they didn't understand what the various taxes fund, reinforcing PCTPA's work to educate and inform the community on the complexities of transportation funding. The RTP's financial element breaks down these revenue sources, providing some clarity for the community.

Because PCTPA has previously advanced STIP funding and has no capital programming capacity for the 2024 RTIP, there are no benefits or negative impacts associated with any proposed capital programming.

Our target share in the 2024 STIP is \$0 excluding Planning, Programming, and Monitoring (PPM) funding. Significant STIP funding was advanced to complete the Lincoln Bypass that resulted in a project with significant benefits to the public but also resulted in an overdrawn balance of approximately \$3.9 million in fiscal year 2028-29 for Placer County's regional choice STIP funding. The PPM funding will total \$1,042,000 over fiscal years 2024/25-2028/29.

#### B. Summary of Requested Programming -

No projects are proposed for programming as part of the 2024 STIP. The PPM funding requested is \$210,000 per year for fiscal years 2024/25 though 2027/28, and \$202,000 in fiscal year 2028/29.

#### Section 8. Interregional Transportation Improvement Program (ITIP) Funding and Needs

The purpose of the Interregional Transportation Improvement Program (ITIP) is to improve interregional mobility for people and goods in the State of California. As an interregional program, the ITIP is focused on increasing the throughput for highway and rail corridors of strategic importance outside the urbanized areas of the state. A sound transportation network between and connecting urbanized areas ports and borders is vital to the state's economic vitality. The ITIP is prepared in accordance with Government Code Section 14526, Streets and Highways Code Section 164 and the STIP Guidelines. The ITIP is a five-year program managed by Caltrans and funded with 25% of new STIP revenues in each cycle. Developed in cooperation with regional transportation planning agencies to ensure an integrated transportation program, the ITIP promotes the goal of improving interregional mobility and connectivity across California.

PCTPA is not currently requesting ITIP funding for projects as part of the 2024 STIP

PCTPA was asked to include a discussion of what the region believes are the most significant interregional highway and intercity rail needs within the region. Although the region has many needs, below are the highest priority projects.

#### **Interregional Highway Needs:**

I-80 and SR65 are the two highest traveled routes in Placer County. I-80 is the main state highway traversing east/west through the County and supports interregional and regional commuting and recreational travel, and national freight movement. SR65 carries traffic between I-80 and rapidly growing communities to the north. Both routes experience significant congestion during peak hours that increases travel times resulting in added pollution and GHG emissions. On-time performance of transit routes in South Placer are challenged on the mainline and, because the mainline is congested, it causes significant congestion slowing transit routes on major arterials in Roseville, Rocklin and Lincoln. The most significant immediate needs for these routes include the \$580 million reconstruction of the 80/65 Interchange and the \$115 million multi-phased widening, future managed lanes and operational improvements to SR 65. The I-80/65 Interchange currently lacks funding to start preliminary engineering. Phase 1 of the SR 65 widening is designed but a \$20 million funding shortfall is delaying construction. Additionally, a feasibility analysis for managed lanes on I-80 from the 80/65 Interchange to the western county line is needed to explore how managed lanes may benefit the corridor.

Needs on other state routes include \$500 million in multi-phased corridor improvements on SR 89 and SR 267 to encourage increased transit use, reduce vehicle miles traveled (VMT), and create a more reliable travel experience for residents and the high volume of visitors in the Resort Triangle area of Lake Tahoe (Kings Beach, Tahoe City and the Town of Truckee). Needed improvements on these routes include transit signal priority modifications, transit queue jumps, and reversible bus-only lanes. The roughly \$10 million first phase will include transit signal prioritization but it is currently unfunded.

#### Intercity Rail Needs:

The UPRR line parallels I-80 throughout Placer County and serves as a transcontinental rail route accommodating freight and passenger services. The J. R. Davis Yard, located in the City of Roseville in Placer County, is the largest classification yard on the West Coast. Approximately 98 percent of all UPRR traffic in Northern California is moved through this yard. The Capitol Corridor intercity passenger rail service runs daily service between Auburn to San Jose, through Sacramento and the East Bay. Because of the heavy freight use, only 1 round trip per day operates between Placer County and Sacramento. The most significant need is the addition of 17.8 miles of track between Roseville and Sacramento, as identified in the California State Rail Plan, to expand intercity passenger rail service to Placer County to 10 round trips a day. The Phase 1 project will construct 6.8 miles of track to accommodate 2 additional round trips and is fully funded. The Phase 2 project will provide for an addition 7 trains per day. It is estimated at \$295 million and is largely unfunded.

Longer term needs include track and station improvements between Auburn and Reno to provide Capitol Corridor intercity passenger rail service connecting the Bay Area, Sacramento and the Lake Tahoe/Reno/Sparks area, as envisioned in the California and Nevada State Rail Plans. The Lake Tahoe/Reno area is a high-volume tourist destination for both the Sacramento Valley and Bay Area communities and major economic driver for Placer County. Preliminary feasibility studies have started to identify costs to improve en-route stations; however, more

detailed feasibility studies are needed to determine the full cost and scope of the engineering work necessary to expand passenger rail service between the Bay Area and Sacramento to Reno/Sparks.

#### Section 9. Projects Planned Within Multi-Modal Corridors

#### Section 10. Highways to Boulevards Conversion Pilot Program

Within the Placer County Transportation Planning Area, a section of SR 49 in the City of Auburn (PM 2.3 to 7.5) is a barrier to multimodal travel across the community due to the lack of contiguous bicycle and pedestrian facilities on the state highway. The highway serves as a primary corridor within Auburn, but the lack of contiguous bicycle and pedestrian facilities inhibits the use of these modes due to the speeds and traffic volume on SR 49.

There are numerous locations within the urbanized areas where the I-80 and SR65 freeways act as a physical barrier dividing the community. As noted above, SR 49 also divides the community of Auburn and inhibits alternate modes. The following locations have been identified for pedestrian and bicycle overcrossings to provide connectivity across the freeway or highway but lack funding:

I-80 near Cirby Way

I-80 near Rocklin Rd/ Sierra College

SR 49 north of Bell Rd

SR 49 near Palm Ave.

SR65 near Blue Oaks Blvd

SR65 near Galleria Blvd

In 2008, the California legislature adopted SB 375. SB 375 requires the California Air Resources Board (CARB) to set performance targets for passenger vehicle emissions in each of 18 Metropolitan Planning Organizations (MPOs) in the state for 2020 and 2035, requires an Metropolitan Transportation Plan (MTP) to include a Sustainable Communities Strategy (SCS) that integrates the land use and transportation components, and amends CEQA to provide incentives for residential and residential mixed use projects that help to implement an MTP/SCS that meets the CARB targets.

CARB initially set reduction targets for the Sacramento region of 7 and 16 percent per capita GHG reduction by 2020 and 2035, respectively. In 2019, CARB increased the 2035 reduction target to

19 percent per capita GHG reduction. SACOG, which covers a six County region including Placer County, adopted the 2020 Metropolitan Transportation Plan/Sustainable Communities Strategy on November 18, 2019, which incorporated the 2040 Placer County RTP adopted on December 4, 2019.

The 2040 Placer County RTP provides a starting place to work toward Placer County's responsibility to address regional GHG targets; and is in alignment with the principles of AB 32 and SB 375. The 2040 RTP contains many goals and policies to reduce vehicle trips and improve air quality. The goal areas containing the most explicit policies relating to GHGs are: Pedestrian, Bicycle, and Low Speed Vehicles (NEVs), Transportation Systems Management, and Integrated Land Use, Air Quality, & Transportation Planning. The Action Element also contains action plans that are intended to further the RTP's air quality-related goals and policies. The action plans include both short-term and long-term steps for each transportation mode. PCTPA works closely with SACOG to reduce GHG emissions through the MTP/SCS planning process.

#### **ACTION REQUESTED**

Direct the Executive Director to coordinate with the region's transit operators to administer the Senate Bill 125 (SB 125) program funding allocation and submit all necessary documentation including amendments.

#### **BACKGROUND**

In July 2023, the State of California passed Senate Bill 125 (SB 125), which serves as a trailer bill to the State's Fiscal Year (FY) 2023/24 budget. SB 125 creates approximately \$5.1 billion statewide, of new one-time source funding to help address transit providers' operating and capital needs. The funding is distributed through two programs, the Transit and Intercity Rail Capital Program (TIRCP) and the Zero Emission Transit Capital Program (ZETCP), over a two-year and four-year period, respectively. As the Regional Transportation Planning Agency (RTPA) for Placer County, PCTPA is administratively responsible for distributing SB 125 program funds to agencies that are eligible to receive TIRCP and ZETCP funding for projects that meet strict criteria established by the SB 125 program's final guidelines released on September 30, 2023. PCTPA has been allocated \$37,851,991 of combined TIRCP and ZETCP funding over the next four fiscal years.

The TIRCP funding program has been an existing competitive funding program that is designed to support transit capital projects that both increase ridership and reduce greenhouse gas emissions. SB 125 included a one-time formula allocation to RTPAs of TIRCP funding. Traditionally, TIRCP funding has been used to support high priority rail or bus capital projects such as existing projects seeking to maintain or obtain federal or local funding commitments, project development for major projects that are seeking to enter or have already entered project development with federal partners, or new TIRCP-eligible projects. Under the SB 125 program, these new one-time formula funds can be used for traditional TIRCP projects and/or to offset or mitigate operating expenses that prevent service cuts and increase ridership for operators.

The ZETCP funding program is new and can be used to support zero-emission infrastructure associated with transit operator's electric fleet charging needs and replace aging vehicles with zero-emission vehicles. Funding can also be used to support operating expenses that maintain existing service levels to retain and/or increase transit ridership.

#### **DISCUSSION**

Pursuant to the SB 125 program's guidelines, PCTPA must submit an initial allocation request to the California State Transportation Agency (CalSTA) for the first year of TIRCP and ZETCP

combined funding, approximately \$18.26 million, by December 31, 2023. The initial allocation request package must identify how capital and/or operating funds will be expended from the TIRCP and ZETCP funding programs and provide a financial performance and service quality analysis for each transit operator requesting the funding. Staff has collaborated with PCTPA's partnering cities/town and the County to identify eligible project funding needs that would be submitted in the initial allocation request package and subsequent SB 125 program funding requests. Ultimately, these projects and the project list may change and be updated throughout the SB 125 program's four-year term, which is allowable per the program's funding guidelines.

Attachment 1 identifies the preliminary project funding needs identified for each transit operator using the combined TIRCP/ZETCP funding available. However, it is important to note the following:

- PCTPA is eligible to claim up to 1% of total TIRCP/ZETCP funding, or \$378,520, to
  administer the program throughout the next four years and beyond, which is being
  requested off-the-top to support PCTPA's staff time and possible consultant costs to fully
  administer the SB 125 program's annual requirements pertaining to financial accounting,
  program reporting, and service performance evaluation of the transit projects and
  operators,
- PCTPA's partnering agencies collectively support the funding being split between
  "regional" projects, totaling approximately \$14.62 million, with the remainder of funds
  being distributed to the region's transit providers for eligible projects consistent with
  PCTPA's process for apportioning funding administered under the Transportation
  Development Act (TDA), with the exception that the City of Auburn receives a \$1 million
  floor to accommodate their current transit capital needs,
- The projects identified in Attachment A are subject to further review and approval by CalSTA, and may be refined and/or possibly replaced on a rolling basis over the next four years and beyond,
- Given the very immediate initial allocation request package's required December 31<sup>st</sup> submittal, PCTPA has coordinated with the region's partnering agencies and transit operators to prioritize program funding towards capital project needs,
- While the Placer region's transit providers have not currently identified any operating needs, SB 125 program funding may be utilized to support future operating needs should they arise and staff can update the project list accordingly, and
- Staff will utilize the current Comprehensive Operational Analysis (COA) and Short-Range Transit Plan (SRTP) planning efforts over the next year to further refine and identify eligible SB 125 program funding needs for the operators so that the one-time available funding is effectively and efficiently utilized moving forward.

Staff presented the preliminary SB 125 project list to the Transit Operators Working Group (TOWG) in October, and subsequently coordinated with the region's three transit providers: Auburn Transit, Placer County Transit (PCT) and Roseville Transit, to refine the project list. PCTPA's Technical Advisory Committee (TAC) reviewed the project list, contained in Attachment 1, at their November 14<sup>th</sup> meeting and concurred with the proposed project list to be submitted with the initial SB 125 funding allocation request package. Staff recommends that the

PCTPA Board of Directors direct the Executive Director to continue coordinating with the region's partnering agencies and transit operators to submit the initial SB 125 program allocation request package and administer all subsequent program requirements, funding requests, and any project amendments, revisions, changes required to fully utilize the funding for addressing the Placer region's transit operating and/or capital needs.

**FUNDING ANALYSIS - PROJECT UPDATE** 

#### **ACTION REQUESTED**

Hear a presentation updating the Board on progress to develop the South Placer-South Sutter Fair Share Transportation Funding Analysis. No specific action is required.

#### **BACKGROUND**

In June 2009, Placer and Sutter counties entered into a mutual settlement agreement relating to the Placer Vineyard and Sutter Pointe Specific Plans. In this agreement, Placer and Sutter counties agreed to establish a program of credits and reimbursements consistent with fair share mitigation requirements for its out-of-jurisdiction traffic impacts, and its impacts on federal and State freeways and highways from the specific plans being developed within each respective County.

In October 2021, a Memorandum of Understanding was executed between Placer and Sutter counties, the City of Roseville and PCTPA, directing PCTPA to facilitate a mutually agreeable scope and structure to develop a fair share transportation funding program for the South Placer-South Sutter region.

In January 2023, the PCTPA Board approved funding agreements with Placer and Sutter counties, and the City of Roseville, authorizing DKS Associates to develop the South Placer-South Sutter Fair Share Transportation Funding Analysis.

#### **DISCUSSION**

PCTPA and DKS Associates initiated work for the South Placer-South Sutter Fair Share Transportation Funding Analysis in February 2023. The project schedule targets completion of the Fair Share Transportation Funding Analysis report by March 2024. Following report completion, additional community and stakeholder outreach will be scheduled in conjunction with adoption hearings targeted for the April – August 2024 period.

The purpose of today's presentation is to update the Board on the progress to develop the Fair Share Transportation Funding Analysis. The presentation will address the following topics:

- Summarize project background and scope activities.
- Project identification.
- SPRTA model refinement to include Sutter County.
- Review land use development assumptions.
- Methodology to identify existing and future transportation network deficiencies.
- Review trip patterns occurring under 2040 conditions.
- Methodology to calculate fair share; and
- Review project schedule, including next steps.

#### **RTIP Adoption**

Rick explained that the state requires that we adopt a Regional Transportation Improvement Program (RTIP) every two years. The RTIP feeds into the State Transportation Improvement Program (STIP). In 2002, the PCTPA Board advanced \$78 million of Placer County's shares to help fund the Lincoln Bypass. As a result, Placer County will not see STIP funding until about FY 2029/30. PCTPA does receive Planning, Programming, and Monitoring (PPM) for staff costs related to projects contained in the RTIP and ITIP. Staff previously sent out an RTIP summary which details the Interregional Highway and Intercity Rail Needs. We added the feasibility analysis of managed lanes on I-80 from the western county line to the SR65 interchange to last year's list. Additionally, the CTC has requested a list of potential candidates for a State Highways to Boulevards Conversion Pilot Program. Rick emphasized that this list does not result in any funding and requested that the TAC provide any edits to the list by COB Wednesday, November 15<sup>th</sup>. The TAC concurred with bringing this item to the Board in December.

#### **SB 125 Project Allocations**

Mike Costa explained that SB 125 was adopted as part of a trailer bill in the state's FY 2023/24 budget. PCTPA's allocation of SB 125 funding is approximately \$37.85 million. The funding is distributed through two programs, the Transit and Intercity Rail Capital Program (TIRCP) and the Zero Emission Transit Capital Program (ZETCP), over a two-year and four-year period, respectively. PCTPA is eligible to claim up to 1% of total TIRCP/ZETCP funding, or \$378,520, to administer the program throughout the next four years. TIRCP is designed to support transit capital projects that both increase ridership and reduce greenhouse gas emissions. ZETCP funding can be used to support zero-emission infrastructure associated with a transit operator's electric fleet charging needs and replace aging vehicles with zero-emission vehicles. Under the SB 125 guidelines, PCTPA must submit an allocation request to the California State Transportation Agency (CalSTA) for the first year of TIRCP and ZETCP combined funding, approximately \$18.26 million, by December 31, 2023. Staff have been working with the transit agencies to identify eligible projects that meet the requirements of these programs. Mike went over the preliminary list of Regional and Transit Operator/Local Community projects identified for these funds, noting that the project list can change. The TAC concurred with taking the SB 125 funding program allocation and administration to the Board in December.

#### **Carbon Reduction Program**

Rick explained that David Melko is leading this effort and is unable to update the TAC due to a conflict. SACOG has initiated a Carbon Reduction Program (CRP) grant program geared toward electrical vehicle deployment, preconstruction of a regional trail network, and programs promoting an alternative to driving alone. PCTPA is applying for a grant to develop a Countywide Electric Vehicle Charging Plan that can be incorporated into local planning documents. The goal is to help prepare for electric vehicle transition and tee up projects for future grant funding. We in the process of meeting with all the jurisdictions and agencies that would be associated with these efforts, including PG&E and Roseville Electric. This was an information item for the TAC and will not be a Board item in December.

#### **South Placer South Sutter Presentation**

Rick explained that David will provide an informational presentation to the Board in December on the South Placer-South Sutter Fair Share Transportation Funding Analysis. The presentation will update the Board on the progress to develop a fair share funding analysis which is being conducted through funding agreements with Sutter and Placer County and City of Roseville.

#### **Funding Strategy Logistics**

Matt explained that there is likely going to be a half-cent transportation sales tax measure brought to the voters within the sales tax district, consisting of the incorporated cities of Lincoln, Rocklin, and Roseville, in November 2024. A recent poll conducted in October shows that approximately 69% are in support of a measure that would help fund the needed regional projects in Placer County, such as the I-80 / SR 65 Interchange. He added that 17% of the sales tax generated would come from outside the district and noted that it would cost the average person about \$10 per month. The measure would also provide for a 25% earmark for local projects. Part of the process in getting a measure on the ballot is going to all the jurisdictions for their approval of the Expenditure Plan. We have worked with the jurisdictions to add this item on their respective agendas in the March – April timeframe. We will continue to update the TAC throughout the process.

#### **Federal Advocacy Update**

Matt explained that he and Mike Costa recently went to the Placer Business Alliance Summit in Washington and met with Senator Padilla and Congressman Kiley where they discussed the regional and national importance of the I-80 / SR 65 project, the critical improvements needed, and the need for funding. They also met with the U.S. Department of Transportation where they explained the project importance. They offered to set up a meeting with the Office of the Secretary. Despite the increase in development fees to fund this project and the potential measure money, we will still have a funding shortfall. To that end, Matt explained we are beginning a two-year pursuit of an INFRA, MEGA, and/or RAISE grant.

Re: State Advocacy Activities -October 2023 Monthly Update

This memo was prepared for the information of Placer County Transportation Planning Agency (PCTPA) and comments on recent developments on state transportation policy, legislation, budget matters, and administrative activities of interest.

#### Environmental Advocates Pressure Newsom Administration on Highway Projects

Recent controversy related to Caltrans' use of transportation funds and allegations of retribution for whistleblowing has captured the attention of the media; members of the California State Legislature, including Assemblymember Laura Friedman, Chair of the Assembly Transportation Committee; and the statewide transportation community.

During the California Transportation Commission (CTC) meeting in October in Madera County, advocates from environmental, equity, and bicycle and pedestrian groups called on the CTC to independently investigate various state highway projects to ensure "full alignment" with the CalSTA Climate Action Plan for Transportation Infrastructure (CAPTI). While CAPTI does not prohibit highway capacity projects, it recognizes that past practices of freeway expansion are not a sustainable way to address congestion. CAPTI also emphasizes the importance of local context for individual projects and recognizes that a one-size-fits-all approach will not work in California's diverse communities.

In a separate letter to Governor Newsom, more than 60 organizations asked for a moratorium on highway and interchange expansions until investigations into Caltrans are concluded. Among the signatories was the Natural Resources Defense Council (NRDC), which has been outspoken about its desire for the state to reduce driving by stopping investments into the state highway system that increase capacity.

Since that controversy erupted, CalSTA released its Draft 2023 CAPTI Annual Progress Report noting that while still investing in highway capacity its achieved significant reductions in vehicle miles traveled (VMT) per transportation dollar invested, meaningful reductions in greenhouse gas emission (GHGs), and improvements in outcomes in disadvantaged communities, other equity metrics, etc.

#### Caltrans Releases Draft 2024 Interregional Transportation Improvement Program (ITIP)

The <u>Draft 2024 Interregional Transportation Improvement Program (ITIP)</u>, which Caltrans released on Friday, October 27, makes strategic investments in multimodal projects that will help improve the interregional movement of people and goods throughout the State of California. It is notable to report that the Draft 2024 ITIP continues to invest in select highway projects in addition to transit, intercity rail, and active transportation projects. The Department will release the Final 2024 ITIP in December,

additional public workshops will be held in January and February, and the CTC will adopt the final suite of programmed projects at their March 2024 meeting. As discussed above, TC is utilizing the release of the Draft 2024 ITIP to reinforce the need for flexibility in statewide policy to develop transportation solutions to address context specific needs as well as commend the Administration for its climate progress in the transportations sector to date.

#### **Legislative Update**

This memo also provides a short summary of outcomes for legislation discussed in last months' status memo. As a reminder, the 14<sup>th</sup> of October was the deadline for the Governor to render decisions on bills passed to him by September:

#### **Updated Bill actions**

#### AB 350 (Aguiar-Curry) -

Status: Chaptered, October 10, 2023:

This bill will provide the Sacramento Area Council of Governments (SACOG) with a two-year extension to submit their next Metropolitan Transportation Plan (MTP)/Sustainable Communities Strategy (SCS) to the California Air Resources Board (CARB) for approval. TC requested the Governor's signature on this measure to ensure that dozens of multimodal transportation capital projects in the SACOG region can compete for state and federal funding in upcoming funding cycles.

#### SB 695 (Gonzalez) -

Status: Chaptered, October 8, 2023

This bill will require the department, beginning January 1, 2026, to annually prepare and make available on its internet website information and data about projects on the state highway system from the prior fiscal year and to present this information and data to the California Transportation Commission at a regularly scheduled commission meeting on or before April 1 of each year. This measure is co-sponsored by the transportation industry.

#### AB 1385 (Garcia) -

Status: Chaptered, October 08, 2023

would authorize the Riverside County Transportation Commission to impose a maximum transportation and use tax of 1.5%, subject to a vote of the people, for purposes of pursuing a local sales tax measure for transportation infrastructure. TC supports AB 1385 and requested the Governor's signature on this important regional measure.

#### SB 335 (Cortese) –

Status: Chaptered, October 07, 2023

This bill authorizes the County of Santa Clara and the County of Ventura and to impose transactions and use tax for purposes of pursuing a local sales tax measure for transportation infrastructure.

#### SB 4 (Wiener) –

Status: Chaptered, October 11, 2023

This bill creates a streamlined by-right approval process for affordable housing projects on qualifying lands owned by churches and independent, non-profit higher education institutions. Qualifying projects must meet labor standards including paying prevailing wages, among other requirements. TC did not have a position on SB 4 but was monitoring the measure given the significant interplay between housing and transportation policy.

#### SB 423 (Wiener):

Status: Chaptered, October 11, 2023

This bill extends and expands the by-right approval process for eligible housing projects created by SB 35 (2017). Requirements for the use of this process include zoning consistency and requirements to pay prevailing wages and/or use a skilled and trained workforce, as defined, for qualifying projects. Final amendments to the bill in the Assembly modified provisions related to the Coastal Act, public meeting requirements, the eligibility of projects in San Francisco, and fire hazard severity zones. SB 423 was enrolled and presented to the Governor. Like SB 4, TC did not have a position on SB 432 but was monitoring the measure.


<u>2023 carry over bills</u> (the author "held" these bills with the intent of setting stakeholder discussions for possible amendments next year; as they are in their second house, they are not subject to the tight limitations other "two-year" bills are).

AB 6 (Friedman) –The bill's intent is to make changes to CARB's review process for sustainable communities' strategies (SCSs), establish additional greenhouse gas emissions reduction targets for 2035 and 2045, and require project nominations for the Solutions for Congested Corridors Program to demonstrate how projects would contribute to achieving greenhouse gas emissions reductions.

AB 7 (Friedman) – This bill would require the California State Transportation Agency (CalSTA), Caltrans, and the California Transportation Commission (CTC) to include in their existing program funding guidelines and planning process the ten guiding principles from the Governor's Climate Action Plan for Transportation Infrastructure (CAPTI). The bill would also require the California Transportation Plan (CTP) to include a financial element summarizing the costs of implementation, as compared to realistically available revenues, and require CalSTA, Caltrans, and the CTC to report on how their

# Placer County Transportation Planning Agency Federal Update

#### **Capitol Hill and Administration**

Capitol Hill. The House of Representatives found a new Speaker. After 22 days without a Speaker of the House, Rep. Mike Johnson (R-La.) won the election by a vote of 220-209. Speaker Johnson began his Speakership by saying his "first priority" is avoiding a government shutdown. The House leadership canceled the originally scheduled two-week recess in hopes of passing the seven remaining FY 2024 Appropriation bills before the November 17 government funding deadline.

Speaker Johnson indicated that he aims to pass another continuing resolution ("CR") funding the government through mid-January 2024 while the pending appropriations bills continue to move through Congress. One option that Speaker Johnson may use is a clean government spending bill covering all twelve appropriations bills. Another potential is a laddered approach to the CR; the laddered CR would extend funding to federal agencies for different periods of time. There are indications the laddered approach will not fare well in the Senate.

While the Senate passed its version of the FY 2024 Transportation-HUD Appropriations bill, the House version remains stalled; the bill was pulled from the House floor again on November 7 when it became clear there were insufficient votes to pass the bill. The White House issued a <u>Statement of Administration Policy</u> (SAP) noting the President would veto the House bill if it was presented to him as is. The Senate Transportation bill passed on November 1 along with two other funding bills in a "minibus" bill with a final vote of 82-15.

Administration. The Federal Railroad Administration announced the Railroad Crossing Elimination grant and Restoration & Enhancement grant NOFOs will be released in November; both programs fund projects related to freight and intercity rail. DOT announced \$82.6 million in Safe Streets and Roads for All (SS4A) grants to 235 regional, local and Tribal communities for planning and demonstration projects to improve safety and help prevent deaths and serious injuries on the nation's roadways. Earlier this year DOT indicated to TFG the planning portion of SS4A was undersubscribed and virtually all eligible applicants received federal planning funding. SS4A will open again in 2024 and local and regional governments are eligible to apply for planning and construction funding.

#### **PCTPA Federal Agenda**

In October, TFG arranged meetings in Washington, D.C. for PCTPA staff to meet with congressional delegation staff and knowledgeable Federal Highways Administration staff. During these meetings, PCTPA focused on introducing Hill and agency staff to PCTPA's goals as well as focusing on key regional transportation infrastructure projects. TFG will assist PCTPA in building and maintaining these key relationships moving forward. TFG also continued working with PCTPA staff to identify and prioritize the Agency's capital projects and policy interests, assisting PCTPA in organizing project development for grant applications and earmark proposals.

#### **Project Funding Opportunities – Grants Calendar & Appropriations (FY2025)**

TFG continued to focus on developing competitive grants and congressionally directed spending opportunities, focusing on setting up opportunities in CY 2024.

Competitive Grants & Earmarks. As noted in our prior update, TFG provided a draft calendar of CY 2024 grant opportunities tailored to PCTPA's project list. Additionally, TFG will continue coordinating with PCTPA staff to develop briefing materials for meetings with your congressional delegation and other relevant Members and committee staffers. While Congress has not completed the FY 2024 appropriations process – as of this writing the House has yet to pass its version of the Transportation Appropriations bill – we will continue to develop advocacy this before the New Year in advance of the formal appropriations request process opening mid-winter CY 2024 for FY 2025.
