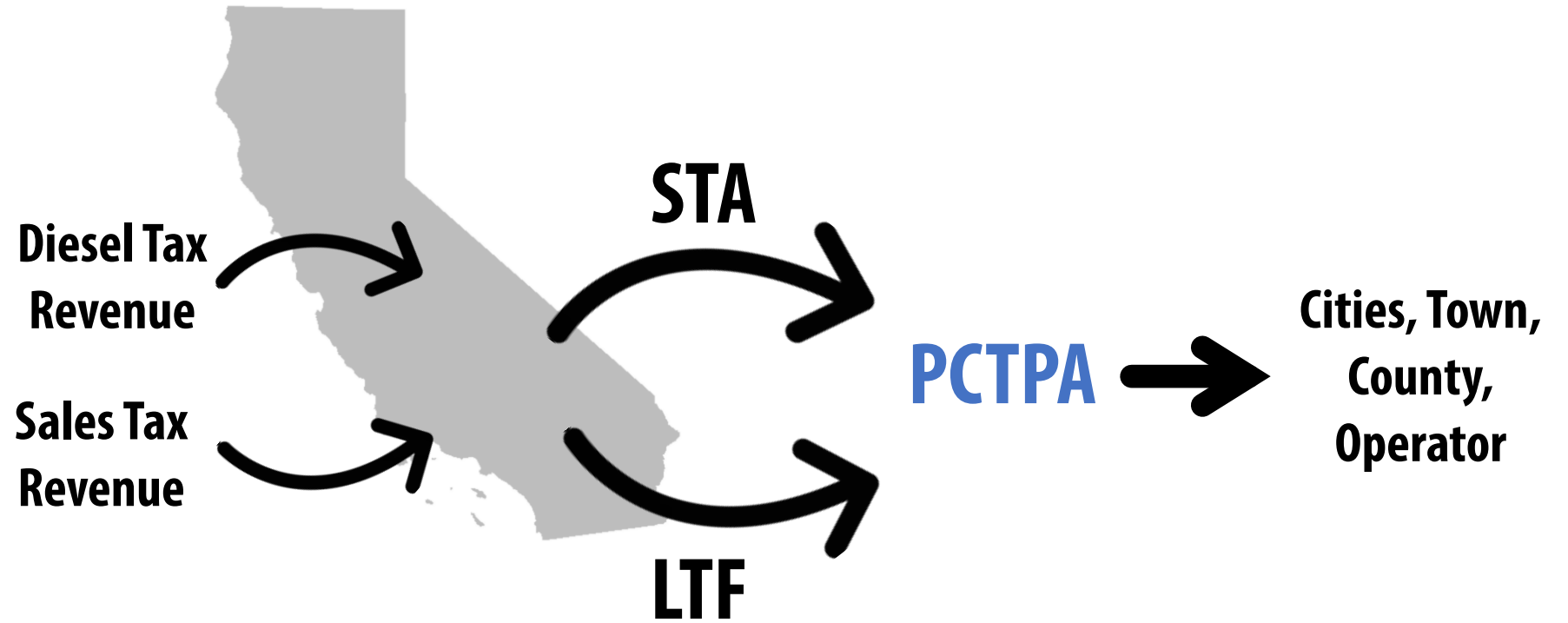

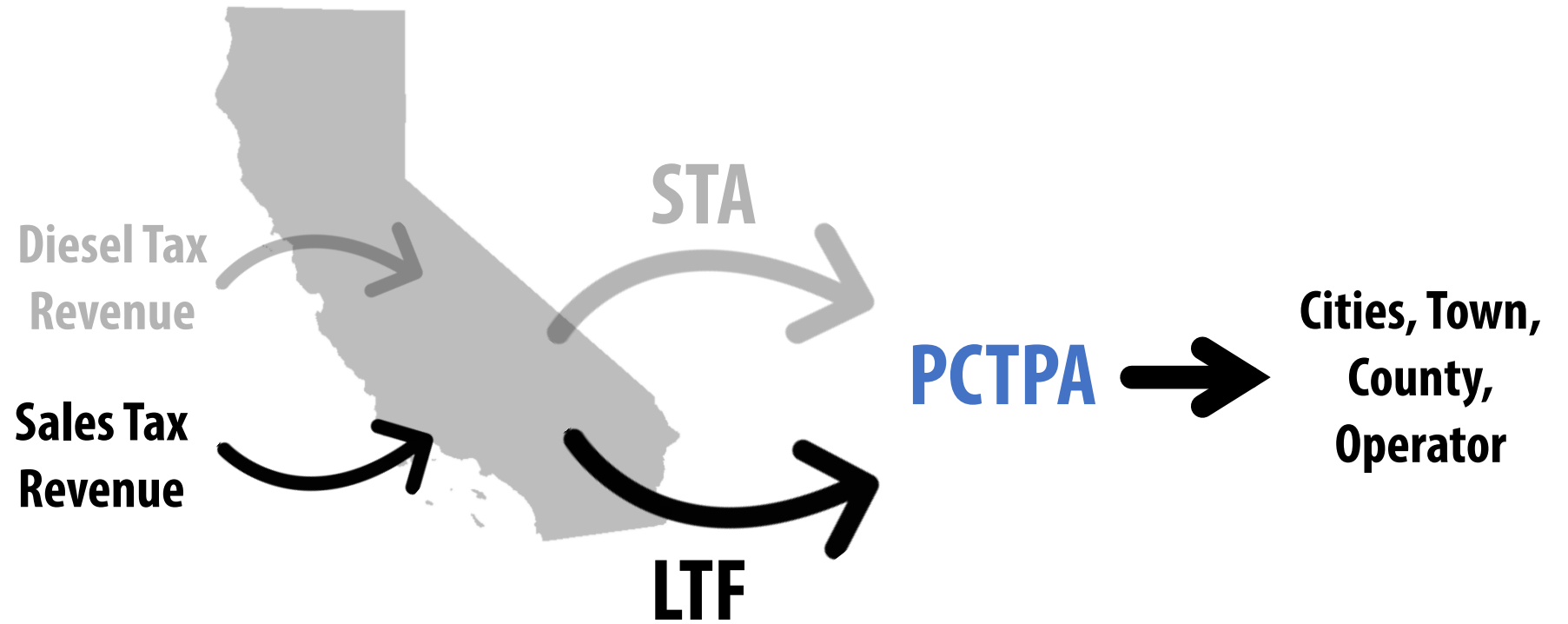

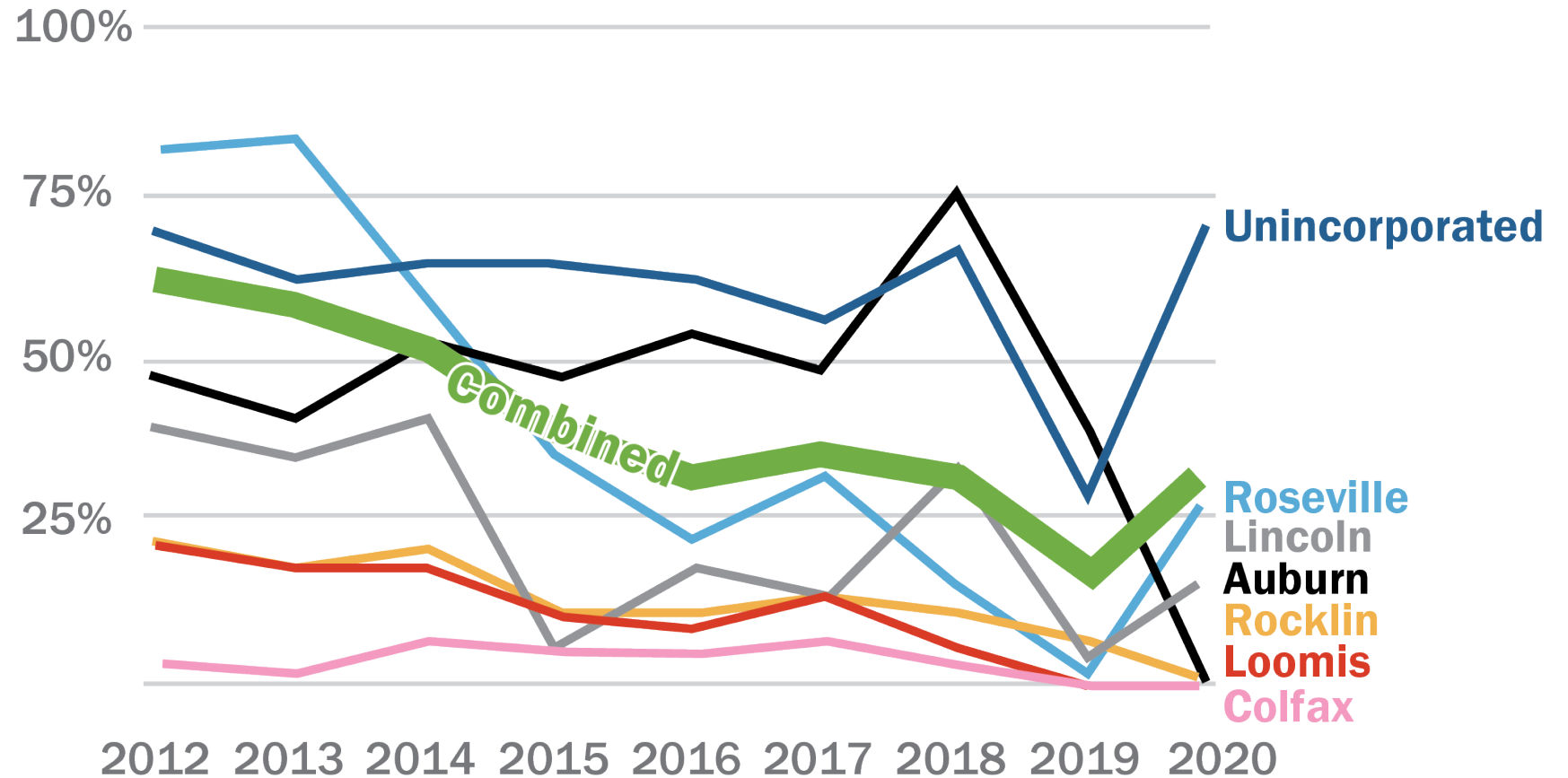

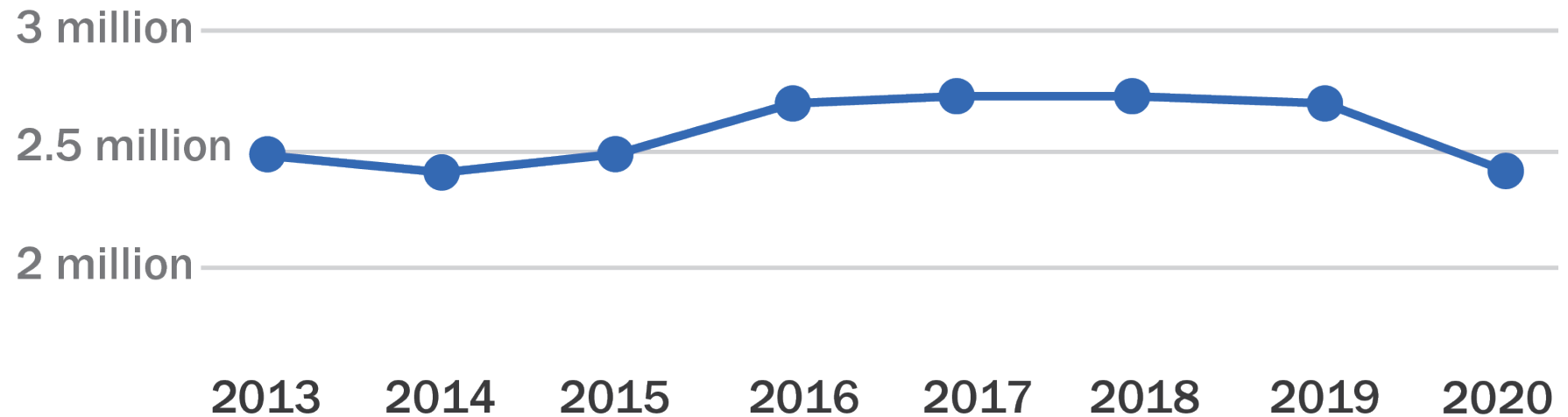

- “X bus route is only during commute time and I need it at midday”

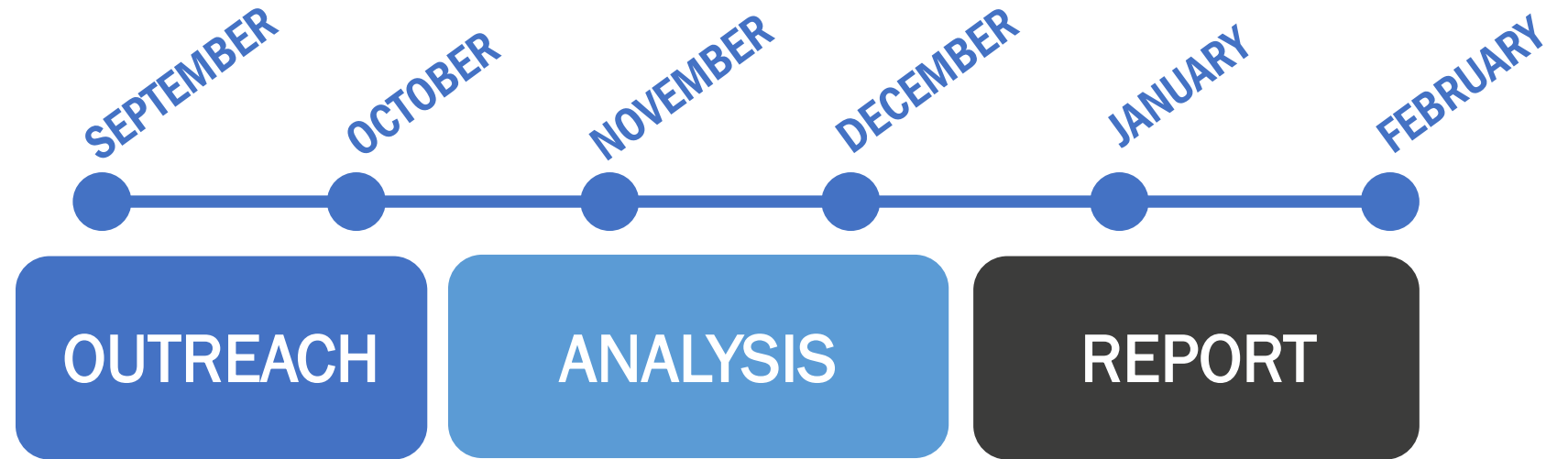
