EXECUTIVE DIRECTOR'S REPORT

Matt Click reported on the following:

- I-80 Auxiliary Lanes
 - ✓ The construction contract was executed on June 16th and contractor is expected to start soon.
 - ✓ Caltrans District 2-in partnership with PCTPA will have a groundbreaking on August 1st.
- CCJPA Third Track from Sacramento to Roseville
 - ✓ Today the CTC staff will be recommending \$25 million in Solutions for Congested Corridors funding for the Third Track Project. Matt recognized David Melko for his efforts in completing the process to apply for these funds which in turn, helped secure this funding.
- There will be no July 26th Board meeting.
- Funding Measure Outreach Campaign Update
 - ✓ Cherri Spriggs, Meraki Consulting, explained the educational and outreach efforts include a steady stream of social engagement through digital marketing, targeted mailers, individual one-on-one stakeholder meetings, community group and partner presentations, partner collaborations, and community group sponsorships.
 - ✓ Andy Galloway, Account Executive 3Fold Communications, explained that one component of the Public Information and Education Campaign Creative addresses senior transportation needs with a focus on emergency response rates. The main message of the campaign focuses on the challenges and inconveniences that people experience with traffic congestion. Andy presented the three :15 second videos which will soon be complemented with :30 second videos that will include narrative. Andy added that the strategy includes a comprehensive media mix targeted toward swing voters that uses print, social media (Facebook / Instagram), connected TV, geo-fencing at special events, and direct mail.
 - ✓ Cherri gave an overview of the events planned from July October 2023.

• Mike Costa and Cory Peterson recently graduated from the Loomis Leadership program.

Michael Garabedian, Placer Tomorrow, provided public comment.

Below are the Consent Calendar items for the August 23, 2023, agenda for your review and action.

 Letter of Task Agreement for Legal Services through June 30, 2026: Sloan Sakai & Yeung LLP

Staff recommends approval of the attached Letter of Task Agreement (LOTA) with Sloan Sakai Yeung & Wong through June 30, 2026 for the amount commensurate with the hourly staff rate provided on the Proposal dated July 7, 2023 and identified in the LOTA. Legal expenditures are included in the FY 2023/24 Overall Work Program and Budget.

2. <u>FY 2023/24 City of Auburn Claims for Bicycle & Pedestrian Local Transportation Funds</u> (LTF) - \$194,500

The City of Auburn has submitted a claim for \$194,500 in Bicycle & Pedestrian LTF funds for FY 2023/24. These funds will be used for the Highway 49 Sidewalk Gap Closure project for work within the City of Auburn. PCTPA is ineligible to claim bicycle & pedestrian LTF funds, and as such the City of Auburn is claiming these funds on behalf of PCTPA. The Auburn City Council approved this claim at their meeting on July 10, 2023. Staff recommends approval.

3. <u>Amendment to FY 2021/22 Local Transportation Funds (LTF) Apportionment to the City of Auburn</u>

Staff is requesting an amendment to the City of Auburn's FY 2021/22 LTF apportionment to reduce it by \$571,904.67, bringing the total apportionment for FY 2021/22 to \$596,767.33. The reduction of \$571,904.67 will be moved to the City's LTF apportionment in FY 2022/23 as shown in Consent Item #4. The reason this change is necessary is because the County Auditor received the allocation instructions to pay the City of Auburn in the amount of \$571,904.67 in August 2022, after the end of the fiscal year. As such, the County Auditor's office was not able to record the expense in their accounting system until FY 2022/23. The amendment to move \$571,904.67 is necessary to change the apportionments to match the recorded expenditures in the County Auditor's system. There is no change in the amount of funds going to the City of Auburn. Staff recommends approval.

4. <u>Amendment to FY 2022/23 Local Transportation Funds (LTF) Apportionment to the City of Auburn</u>

Staff is requesting an amendment to the City of Auburn's FY 2022/23 LTF apportionment to increase it by \$571,904.67, bringing the total apportionment for FY 2022/23 to \$1,638,779.67. The increase of \$571,904.67 is being moved from the City's LTF

apportionment in FY 2021/22 as shown in Consent Item #3. The reason this change is necessary is because the County Auditor received the allocation instructions to pay the City of Auburn in the amount of \$571,904.67 in August 2022, after the end of the previous fiscal year. As such, the County Auditor's office was not able to record the expense in their accounting system until FY 2022/23. The amendment to move \$571,904.67 is necessary to change the apportionments to match the recorded expenditures in the County Auditor's system. There is no change in the amount of funds going to the City of Auburn. Staff recommends approval.

5. Reprogramming CMAQ Funding to the City of Roseville's Dry Creek Greenway Trail, Phase 1 Project from the Dry Creek Greenway Trail, Phase 2 Project, Mahany Park Trail Design and Construction Project, and the Stoneridge - Orvietto Bike Trail Project - \$6,102,736

The Dry Creek Greenway Trail, Phase 1 project (PLA19910) will construct a Class 1 bike trail along Dry Creek, Cirby Creek and Linda Creek from Riverside Avenue/Darling Way to Rocky Ridge Drive. On August 8, 2023 the City of Roseville opened construction bids for the project. The low bid exceeded the engineer's estimate by \$5,880,357.50 and exceeds available contingency funds. In order to fully fund and award the project, including additional construction contingency funding, the City is requesting the reprogramming of a total of \$6,102,736 in CMAQ funds from three other multi-use trail projects: \$1,050,736 from the Dry Creek Greenway Trail, Phase 2 project (PLA25833), \$2,526,000 from the Mahany Park Trail Design and Construction project (PLA25849), and \$2,526,000 from the Stoneridge - Orvietto Bike Trail (PLA25863). The PCTPA Board of Directors approved the programming of CMAQ funding for all three projects at the March 2023 meeting. The reprogramming noted above leaves \$10,000 of CMAQ funding on both the Dry Creek Greenway Trail, Phase 2 project and the Mahany Park Trail Design and Construction project in order to maintain federal National Environmental Policy Act (NEPA) review eligibility. Staff recommends approval.

This letter, when countersigned, authorizes work under the "Master Agreement between the Placer County Transportation Planning Agency (PCTPA) and Sloan Holtzman Sakai LLP" dated August 23, 2023. This contract shall supersede Letter of Task Agreement #23-01 which ends on September 30, 2023.

- 1. Incorporated Master Agreement: This Letter of Task Agreement (LOTA) is the statement of contract-specific requirements applicable to the work effort to be undertaken by Sloan Sakai Yeung & Wong LLP to provide legal counsel to PCTPA. PCTPA also (1) administers the South Placer Regional Transportation Authority (SPRTA), (2) acts as the Placer County Airport Land Use Commission (ALUC), (3) acts as the Western Placer Consolidated Transportation Services Agency (WPCTSA), (4) is a member of the Capitol Corridor Joint Powers Authority, and (4) is designated as the transportation sales tax authority for Placer County by the Placer County Board of Supervisors. PCTPA also currently leases office space in the Nevada Station office building which is owned by SPRTA. It is understood that this agreement and the incorporated Master Agreement applies to these ancillary interests in which PCTPA is associated. For the purposes of this LOTA and the Master Agreement, PCTPA and the ancillary agencies, authorities and interests will be called "PCTPA".
- 2. Term: Consultant services are to commence September 1, 2023 and shall be completed in such a sequence as to assure that services are completed in a timely manner. This letter of task agreement shall end on June 30, 2026. At the end of the agreement term, PCTPA will have the option to exercise two (2), one (1) year renewal options. This contract supersedes Letter of Task Agreement #23-01 which ends on September 30, 2023. During the term of this contract, you are not to engage in other work that would be deemed a conflict of interest with PCTPA or agencies in which PCTPA interests.
- 3. <u>Scope of Services:</u> Consultant will perform the tasks described below:
 - a. Provide legal review and advice to PCTPA on documents, agreements, and responsibilities relating to transportation planning and funding. Typical duties might include review of memoranda of understanding and funding agreements between agencies and analysis of legislation as it may affect PCTPA programs.

BACKGROUND

Placer County Transportation Planning Agency (PCTPA) has maintained a website, pctpa.net, for many years with the latest iterations of the website supported by WordPress. As PCTPA has evolved and encompassed other ancillary agencies, including South Placer Regional Transportation Authority (SPRTA), Western Placer Consolidated Transportation Services Agency (WPCTSA), and the Airport Land Use Commission (ALUC), an outside vendor has been needed to redesign the website. The current iteration of the website with WordPress has existed since the early 2000's and needs an update. Updates and postings to the existing website proved to be time-consuming and cumbersome.

DISCUSSION

In March of 2023, staff sought out website design services specifically geared toward government agencies. Important criteria for establishing a new website were:

- 1. Compliance: Ability to ensure the new website kept us compliant with state and federal guidelines, and specifically the Brown Act;
- 2. Accessibility & Security: The website needed to be ADA compliant and also have the ability to translate languages to assure that our Title VI standards were met and those with limited English proficiency were able to access the information on the website;
- 3. Transparency: The public, partner agencies, Board Members, and other interested parties should be easily able to find the information quickly and efficiently.
- 4. Ease & Control: Staff members wanted to confidently post an agenda and upload images and documents;
- 5. Training & Support: Staff wanted to be properly trained and access support if needed.

PCTPA received four proposals which included design and setup as well as annual fees. Proposals ranged from \$1,250 for setup/design plus \$4,260 in annual fees to \$31,953 for setup/design plus \$13,654 in annual fees. Proposers were uniquely geared to local municipalities that have a wide range of departments such as fire / police, transit, and sewer. PCTPA is somewhat unique as it specializes in transportation specifically and also has ancillary agencies (SPRTA, WPCTSA, and ALUC), and the agencies' needs fall more within a special district category.

Proposals were evaluated and ranked and the website agency that best served our needs was Streamline, which came in at \$1,250 for an initial setup/design and an annual fee of \$4,260. Streamline specializes in special districts and comes highly recommended from the El Dorado County Transportation Commission (EDCTC). These costs were budgeted in FY 2022/23 Overall Work Program and Budget (OWP) and ongoing annual costs are accounted for in the FY 2023/24 OWP.

Over the past several months, PCTPA staff has been working with Streamline on creating the new pctpa.net website and staff will be providing the Board with a brief overview of its features.

BACKGROUND

Considering equity in transportation planning and project investment has become an important national, statewide, and regional topic over the last few years. Competitive funding programs at all these levels have begun incorporating equity metrics into their evaluation criteria for determining project funding awards. In the greater, six-county Sacramento region, the Sacramento Area Council of Governments (SACOG) has led robust planning and public engagement efforts to define and promote equity in its programs and funding opportunities through the implementation of its Race Equity Action Plan and Race Equity & Inclusion Working Group. To complement these efforts, Placer County Transportation Planning Agency (PCTPA) staff recognize the importance of understanding what equity means for Placer County and how it can be considered as one of many lenses for planning, funding, and implementing the region's transportation network, projects, and programs.

DISCUSSION

With the help of PCTPA's on-call communications consulting team, DKS Associates (DKS), staff has begun preparing an equity study to help guide the agency's transportation planning and program funding efforts moving forward. Specifically, the equity study is anticipated to result in the following actions:

- Identify transportation burdens and barriers specific to the PCTPA planning and service area
- Bring equity into one of the many lenses used by PCTPA for project planning and permitting processes,
- Establish targets to measure transportation equity in Placer County,
- Update equity related policies in the PCTPA Regional Transportation Plan (RTP), and
- Use an established equity study and RTP policies to leverage discretionary funding opportunities for the Placer region.

Completing these actions will involve identifying and collaborating with key disadvantaged and/or other underserved populations to understand their respective transportation needs and concerns. Additionally, an equity index guidance document will be created to help with evaluating the Placer region's transportation projects and programs that some populations may be unable to access and/or fully benefit from. Staff will use quantitative data and other well-established demographic

data tools to assist with implementing the equity study's actions and support the project's overall planning efforts.

Staff currently anticipates conducting a series of stakeholder outreach and focus groups over the next couple of months, then bringing back preliminary equity information and data to the PCTPA Board of Directors in October for discussion. Draft policies and recommendations for the RTP and an updated Public Participation Plan are further anticipated to be brought to the Board in December for review and consideration. SUBJECT: STATUS REPORT

RTP 2050 2nd Round Outreach

Every five years, PCTPA updates its Regional Transportation Plan (RTP) to convey the policy direction, projects, and funding recommendations to meet the needs of Placer County's transportation system. The previous update was adopted by the Board in 2019, and had a horizon year of 2040. The new update will extend the plan until 2050. It will be completed as a parallel effort to SACOG's Metropolitan Transportation Plan/Sustainable Communities Strategy (MTP/SCS), known as the 2025 Blueprint, planning efforts.

Public involvement is critical to the success of the RTP. Regional Transportation Planning Agencies (RTPAs) are required to implement a public involvement process, including opportunities for private and public operators of transit and freight, tribal governments, local cities and communities, the general public, and other interested/affected stakeholders. The RTP will also include an effort to reach out to and solicit feedback from underserved and/or disadvantaged communities within Placer County.

PCTPA conducted the first round of public outreach for the RTP in October through December 2022. During this engagement period, staff attended numerous pop-up events throughout Placer County, conducted three public workshops (two virtual and one in-person) and hosted an online survey that was responded to by over 1,100 people. The outreach's objective was to broadly assess the public regarding their transportation investment priorities. A summary of this outreach and its results were presented to the PCTPA Board on March 22, 2023.

A second round of public outreach, including a new survey, is planned to begin in September 2023, and will focus on prioritizing specific regional projects for the RTP. Projects identified in the survey consist of various modes, including roadway, transit, and bicycle/pedestrian projects. PCTPA staff also plans to attend various local pop-up events in each of Placer's jurisdictions to share information about this survey effort and project information with the public. The tentative schedule for these events is as follows:

- Auburn: Old Town Farmers Market (October 14, 2023)
- Colfax: Railroad Days (September 17, 2023)

In addition to these pop-up event, PCTPA staff will host two virtual workshops (October 18th and 19th), and one in-person workshop at PCTPA's offices in Auburn (October 17th). We are also presenting at each City/Town Council (with the exception of Roseville, where we will attend their Transportation Commission) throughout the months of August and September 2023.

RTP 2050 Timeline Extension & Interim RTP

In accordance with state law, PCTPA updates its RTP every five years. The previous update (known as RTP 2040) was adopted in 2019. PCTPA's next update (known as RTP 2050) must be adopted by the end of 2024. Concurrently, SACOG is updating its regional Metropolitan Transportation Plan/Sustainable Communities Strategy (MTP/SCS), known as the 2025 Blueprint.

PCTPA's and SACOG's planning processes for these long-range transportation planning documents are intrinsically tied together. Per a Memorandum of Understanding (MOU) with SACOG as the federal Metropolitan Planning Organization (MPO) for Placer County, PCTPA relies on SACOG for many core components of its RTP, including demographic and financial forecasting, air quality modeling, and financially constrained transportation project lists that must align exactly with each other. SACOG is extending their 2025 Blueprint update timeline to adopt the final plan by the end of 2025, which allows more time for community engagement and aligns the 2025 Blueprint with both the Bay Area's and San Joaquin Council of Governments' MTP/SCS updates. As such, PCTPA must adjust the RTP 2050 update timeline to also adopt by the end of 2025. By doing so, SACOG, PCTPA, and El Dorado County Transportation Commission (EDCTC) will all be on the same RTP update schedule where each agency's RTP will be adopted in the same year after 2025.

As part of the timeline extension, SACOG is currently preparing an interim MTP/SCS update that will allow them to extend their full 2025 Blueprint adoption schedule while remaining within air quality conformity guidelines. This is expected to occur in fall 2023. During the process of requesting a timeline extension from Caltrans for PCTPA's RTP, staff learned that PCTPA also needs to adopt a similar interim RTP. This will include minimal changes to the document itself and allow PCTPA to remain in compliance with state law and do a full 2025 RTP adoption by the end of 2025. Staff anticipates this interim update will occur in early 2024.

Staff will continue to update the Board as more information becomes available regarding this matter.

FY 2024/25 Unmet Transit Needs Assessment and Comprehensive Operational Analysis / Short-range Transit Plan Outreach/Engagement Process

PCTPA will begin the annual Unmet Transit Needs (UTN) Assessment outreach process on September 5, 2023. This year's outreach/engagement process will involve the availability of an online survey (available in English, Spanish, and Tagalog), informational e-mails sent to various public and partnering agencies regarding the UTN process and survey availability, and social media posts to solicit stakeholder engagement through the available survey. Additionally, PCTPA staff plans to visit each member jurisdiction during August through October to conduct in-person

UTN presentations and/or make information available about the process and where members of the public can provide their input regarding transit needs (through the survey).

Concurrent with this year's UTN Assessment process, staff has begun planning efforts for the Comprehensive Operational Analysis (COA) and Short-range Transit Plan (SRTP) project, which started in July 2023. The COA/SRTP project implements additional transit outreach and public engagement activities, including the administration of an onboard transit survey (on Placer County Transit and Auburn Transit buses/services) and focus group meetings with various stakeholders throughout the region. This process will also be soliciting public feedback on public transit systems and services provided in Placer County alongside the UTN Assessment survey. Staff will coordinate both the UTN and COA/SRTP outreach and engagement activities to avoid duplication of efforts and reduce confusion and/or fatigue.

The schedule, below, provides a timeline for this year's UTN Assessment process, concurrent with the COA/SRTP outreach/planning efforts occurring in September and October. The UTN Assessment process is anticipated to be completed in February 2024, with a draft report and staff recommendation regarding whether there are any unmet transit needs that are reasonable to meet for the Board's review/determination. The COA/SRTP planning process and additional public engagement will continue through Spring 2025, which is when the project will be completed. Starting September 5th, public comments regarding unmet transit needs can be provided through PCTPA's unmet transit needs survey (which will be available online at https://www.pctpa.net/unmet-transit-needs), via e-mail to mcosta@pctpa.net, or by calling Mike Costa at (530) 823-4029. Comments will be accepted from September 5th through October 31st, 2023.

On behalf of Smith, Watts & Hartman (SWH) and Politico Group (PG) I am pleased to provide the following report to the Placer County Transportation Planning Agency (PCTPA) on state legislation, budget matters, and administrative activities of interest to PCTPA.

LEGISLATIVE STATUS

The Legislature is on summer recess until Monday, August 14. Bills in either Appropriations committee have two weeks to move ahead or become ineligible until next year.

STATE ADVOCACY

Small Cities – Balancing state allocations.

A framework for addressing the relatively small allocations from SB 1 and prior local agency fuel tax revenues was developed and presented to management in mid-July. The paucity of revenue allocated results in delayed application of the available resources to meet the city maintenance and rehabilitation needs, not to speak of meeting mobility connections and non-motorized transportation projects. With the relatively small annual allocations available for smaller localities, major project needs require city management to assemble the revenue over time and watch the cost to deliver increase.

A concept was presented despite the fact that some policy makers have long been loath to make changes to these formulas that have stood the test of time, but this memo may provide solid suggestions that don't "rock the boat" but also achieve modest increases in smaller city resources.

OTHER KEY LEGISLATION

<u>SB 695</u> (**Gonzalez**) – Passed out of the Assembly Transportation Committee by unanimous vote. The bill is now resident to the Assembly Appropriations Committee.

Status: SB 695 must be approved by the Appropriations Committee by Friday, September 1.

<u>AB 1335</u> (Zbur) - This bill is intended to make changes to the housing projections included in regional transportation plan/sustainable communities' strategies (RTP/SCS)s and adds additional reporting requirements for local governments.

Status: Senate Transportation; held over to 2024.

Governor Signs Budget, Trailer Bills, and Infrastructure Streamlining Package

Following the June 26 announcement of a three-way deal on the 2023-24 state budget between Governor Gavin Newsom, former Assembly Speaker Anthony Rendon, and Senate President pro Tempore Toni Atkins, the Legislature quickly approved, AB 102 (Committee on Budget), which made changes to the previously approved Budget Act of 2023 (SB 101, Committee on Budget), as well as a series of 19 budget trailer bills.

The "Big Three" were able to reach agreement by removing acceleration of the controversial Delta tunnels project from the Governor's infrastructure streamlining package and the Legislature subsequently approved five policy bills that include the majority of the Governor's proposals, as well as Legislative proposals related to equity in infrastructure delivery.

Notably, the overall 2023-24 spending package provides funding to help avert transit agencies from toppling off a "fiscal cliff" attributed to flagging ridership and the exhaustion of federal aid related to the COVID-19 pandemic. Several provisions of SB 125, the transit funding trailer bill, have proven controversial, and we expect there may be opportunities to enact changes to the bill in future trailer bill clean-up later this summer.

Governor Appoints First Director of New Oil Watchdog

Governor Gavin Newsom appointed Tai Milder as the first Director of the Division of Petroleum Market Oversight within the California Energy Commission (CEC) – the next step in the Governor's effort to hold oil companies accountable following last year's record gasoline price spikes. Milder has served as Counsel to the Assistant Attorney General for the Antitrust Division at the U.S. Department of Justice since 2022, where he also served as a Trial Attorney from 2009 to 2017 and again in 2021. Milder served as a Deputy Attorney General in the Antitrust Law Section at the California Department of Justice from 2019 to 2021. He was Counsel at Robins Kaplan LLP from 2017 to 2019. Milder served as a Special Assistant U.S. Attorney at the U.S. Department of Justice from 2014 to 2015. He earned a Juris Doctor degree from the University of California, Berkeley School of Law and a Bachelor of Arts degree in Political Science from the University of California, Berkeley.

Placer County Transportation Planning Agency Federal Update

Capitol Hill and Administration

Both the House and the Senate are on August recess. The Senate returns on September 5 and the House reconvenes on September 12. The legislative calendar is quite full, with 12 annual spending bills – including the Transportation Appropriations bill – and FAA reauthorization requiring passage or extension by September 30. A federal government shut down may occur as early as October 1 if Congress does not pass appropriations legislation or a continuing resolution providing temporary funding for federal agencies. A shutdown could impact federally funded construction projects and transit funding, and we are tracking this closely.

The House and Senate published lists of congressional earmarks included in the Transportation Appropriations legislation. The House list is here and the Senate list is here. Both earmark lists are searchable by several factors including project name or Member/Senator last name. Funding for earmarked projects is not guaranteed; the legislation must be approved by Conference Committee and both bodies once again, and then be signed into law by the President.

The White House updated its "Open and Upcoming Infrastructure Funding Opportunities" webpage located here. This webpage provides a good overview of many Bipartisan Infrastructure Law-funded programs but should not be viewed as comprehensive. We use this resource along with many other sources to ensure we have a complete picture of federal funding opportunities related to transportation and PCTPA projects, including discussions with key White House and agency officials and staff, daily reviews of the Federal Register and agency resources, and TFG grants tracking.

PCTPA Federal Agenda

TFG worked with PCTPA staff to identify and prioritize the Agency's capital projects and policy interests. We assisted PCTPA in organizing project information development for grant applications and earmark proposals and identifying information gaps. This process helps us assess project readiness and prepare for upcoming funding opportunities and related advocacy efforts on Capitol Hill and at federal agencies. Specifically, we are working with staff to develop the following project information:

- Budget (funds available / funds sought)
- Project status (e.g., whether project is included in TIP, status of preconstruction engineering and design, environmental review status, right-of-way status, construction readiness)
- Timeline

Project Funding Opportunities – Grants Calendar & Appropriations (FY2025)

There are two main funding opportunities TFG focuses on for PCTPA: (a) competitive grants administered by federal and state agencies, and (b) congressionally directed spending, also known as congressional earmarks.¹

Competitive Grants. TFG will provide a calendar of open and upcoming grant opportunities tailored to PCTPA's project list. In addition to preparing to respond to Notices of Funding Opportunities ("NOFOs"), TFG will assist PCTPA in developing project awareness and political support in Congress and at the US Department of Transportation this fall.

Earmarks. TFG is coordinating with PCTPA staff to develop briefing materials for meetings with your congressional delegation and other relevant Members and committee staffers. While Congress currently working through the FY 2024 appropriations process, we are preparing now for possible earmark advocacy this fall in advance of the formal appropriations request process opening midwinter for FY 2025.

¹ The US Senate refers to earmarks as "Congressionally Directed Spending" or "CDS" while the House of Representatives nomenclature is "Community Project Funding" or "CPF." They are essentially the same thing with nearly identical processes and submittal timelines (winter/early spring).
